

# Health-related quality of life in patients with psoriatic arthritis

## Introduction

- Psoriatic arthritis is an inflammatory type of arthritis associated with the chronic skin condition psoriasis
- It is classified as a seronegative spondyloarthropathy due to the absence of rheumatoid factor (Krueger 2002)
- Prevalence in general population varies between 0.04 and 1% (Gladman 2005). In one survey, about 85% of patients with PsA reported that they had psoriasis. One third of those with psoriasis reported joint stiffness (National Psoriasis Foundation 2002)
- Patients with moderate to severe psoriatic arthritis have a significant impairment in quality of life compared to general population (Husted 2001, Krueger 2002)

## Objective


- To describe in patients with psoriatic arthritis in Spain: • Demographic and clinical characteristics
  - · Health-related quality of life
  - Loss of productivity due to the illness
- Patients included in the study: 287
- PASI: Mean score was low with a mean value 3.73
- Number of swollen joints: Mean value 2.62
- Number of tender joints: Mean value 4.97

## HAQ:

 40.0% of patients have any problems to arise or to realize activities like vacuuming, yard work or to get in and out of a car



# **Methods**

## Study design

- Cross-sectional, observational, multicenter study in 18 centres in Spain Inclusion criteria;
  - Patients over 18 years old - Diagnosis of psoriatic arthritis confirmed by dermatologist or rheumatologist
  - Ability to understand and answer correctly the questionnaires used in the study
- Exclusion criteria:
  - Patients participating in a clinical trial
    - Patients treated with a biological therapy other than infliximab
  - Patients with an axial involvement
- Data collection

## Demographical and clinical data (age, sex, disease duration)


#### • Assessments:

- Psoriasis area and severity index (PASI; range 0-72; higher scores represent high severity)
- = Health assessment questionnaire (HAQ; four different responses: without any difficulty, with any difficulty, with some difficulty, with much difficulties and unable to do)
  - Number of swollen and tender joints
  - EuroQol 5D (EQ-5D; range 1-3; higher scores represent worst HRQL)
  - Short Form 36 (SF-36; range 0-100; higher scores represent best HRQL)

# Results

- EQ-5D:
  - The "pain" domain demonstrated the worst score (mean = 1.86) 48.1% of patients reported that they have some difficulties or they felt unable to do daily activities
  - Visual Analogue Scale (VAS) showed a mean score of 60.41


## Figure 2. Mean values EQ-5D



## SF-36:

- Mean value for the physical component summary (PCS): 37.88
- Mean value for the mental component summary (MCS): 46.90

## Conclusions

- Patients with psoriatic arthritis have a great impairment in their quality of life
- Due to the physical difficulties associated with the disease, patients with psoriatic arthritis have a loss of productivity and a reduction of their incomes
- The bodily pain join to physical disturbances are likely the most important factors that interfere patients life
